The objective of this portfolio is to deliver long term capital growth through equity centric investments. The portfolio does not adhere to the guidelines set by Regulation 28.

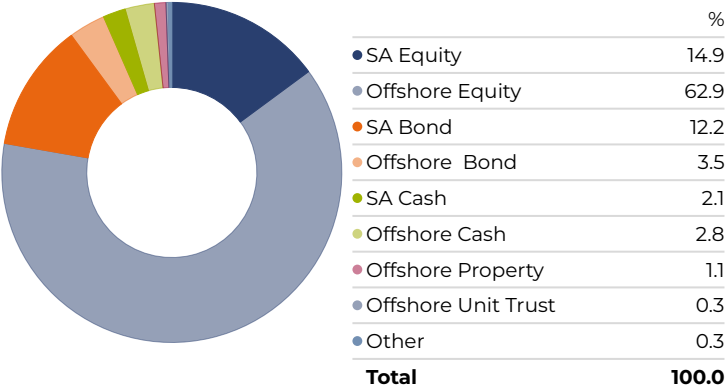

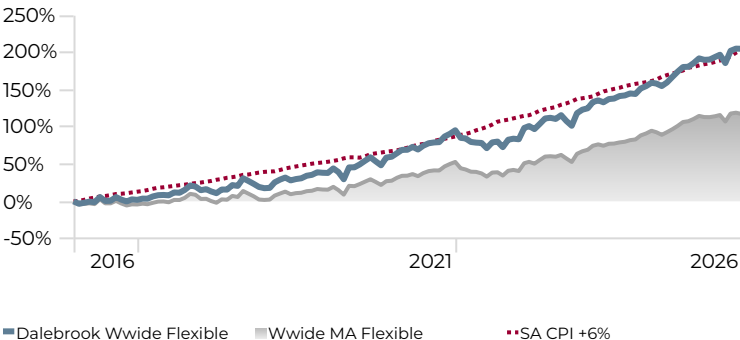
